Reading: Webpage interview with a Professor of Legal History; Article about Greece’s first written code of laws; Napoleon’s Code Listening: Four monologues about Habeas Corpus Act; Listen better: identifying the general topic. Interview with a lawyer Speaking: Discussing the Magna Carta or Great Charter; Making suggestions; Talking about the role of The Bill of Rights; Acting out a dialogue. Writing: A mini-composition “Magna Carta Causes And Contents” Grammar: Present Perfect Simple : time expressions; Since/for; Already/yet;

Constitutional Law. The Constitution (Ukraine, the United Kingdom, the USA). The System of Government (Ukraine, the UK, the USA). Ukrainian Citizenship Vocabulary: state, state symbols, independence, citizen, rights, powers and duties, national government, legislation, the executive power, the judicial power, inviolability, equal before the law, social security, obligations before society, precedents and traditions, violation of the Constitution. Reading: Constitution of Ukraine. Ukrainian Citizenship Listening: Listen better: hearing the present perfect. Semester 5,6.

Sources of Legal English. What makes modern English difficult? What makes international Legal English difficult? Elements of legal writing in ESP context (grammar focus). Punctuation for legal writing. The Court System of Ukraine, Great Britain and the USA. Legal Prosecution in Ukraine and Anglosphere countries. Standards for legal writing. Contracts: Performance, termination and remedies. Meeting, getting and getting down to business. Court advocacy. Chairing a formal meeting. Business and International law abbreviations and initialisms. Foreign terms used in international legal English. Phrasal verbs for International Legal English. Vocabulary: The Constitutional Court, the Commercial Court, criminal and civil cases, the Supreme Court, Court of Appeal, district courts, the Court of International Trade, the Local Court, to administer justice by the courts, delegation of the functions, judicial proceedings, legality, openness of trial, participants in a trial, court decisions, contempt of court. Reading section. Giving legal advice; Describing court system in different countries. Grammar: Will, might and may: prediction patterns. Understanding instructions. Business Law. Sole traders. Partnerships. Companies. Incorporating a Company. Shares and Share Capital. The Language of Drafting. Paperwork. Grammar: Second and Third Conditionals/Wishes/Unreal Past. Mixed Conditionals. Employment law. Working in Employment Law. Being an Employer. An Employment Contract. Acting for an Employer. Acting for an Employee. Employment Discrimination. An

Grammar: Modal Auxiliary Verbs (upper-intermediate contexts).

Writing focus: an analytical essay, a synthesis essay, a compare and contrast essay.

Semester 7.

International Legal English. Summarizing Specific Grammar, Vocabulary, Speaking, Writing Aspects: Introductory issues to Legal English system and structure (general overview); Grammar for Legal Writing; Punctuation for Legal Writing; Sentence Structure; Legal Writing Standards: Dates, Numbers, Citations and Headings; Terminology and Linguistic Peculiarities. Elements of Good Style: Clarity, Consistency, Effectiveness. What to Avoid. British and American English peculiarities in terms of International Legal English. Contracts: Structure and Interpretation. Contract Clauses: Types and Specimen Clauses. Drafting Legal Documents: Language and Structure. Correspondence, Memoranda and Essays. Applying for a Legal Position. Self-Study Exercises. Aspects of Spoken English;

ESP topical vocabulary focus: speech cliches and patterns. Meeting, Greeting and Getting Down to Business. Interviewing and Advising. Dealing with Difficult People: Ten-Point Guide. Court Advocacy. Negotiation. Chairing a Formal Meeting. Making a Presentation. Telephoning.

Writing focus: a reflective essay, a persuasive essay, an evaluation essay, a cause-and-effect essay.

Application Procedure. Writing a motivation letter for an academic course on an exchange students programme/a cover letter/a resume (addressing the recipient; introducing yourself; stating the purpose of writing; describing personal skills and accomplishments; demonstrating understanding of the programme and the environment; specifying; giving reasons/causes; sequencing and linking ideas; persuading the reader; thanking and finishing (motivation/cover) letter; writing a complimentary clause). Time management. Performing during the interview (greeting the interviewer(s) and introducing oneself; describing educational background / profile / previous experience; selling oneself, i.e. making oneself appealing and successful with a potential employer; answering different types of standard open-ended questions; asking related to the situation open-ended questions; giving one's opinion; cause-and-effect reasoning; thanking the interview panel; body language during the process of interaction.

Self-study focus. Reading and discussing job-related texts on International Law issues. Searching for and processing information. Developing skimming and scanning skills: extracting main and detailed information. Skimming; scanning; reading strategies; guessing the meaning of unknown words; predicting the content and vocabulary (in talks and texts); understanding text organization.
